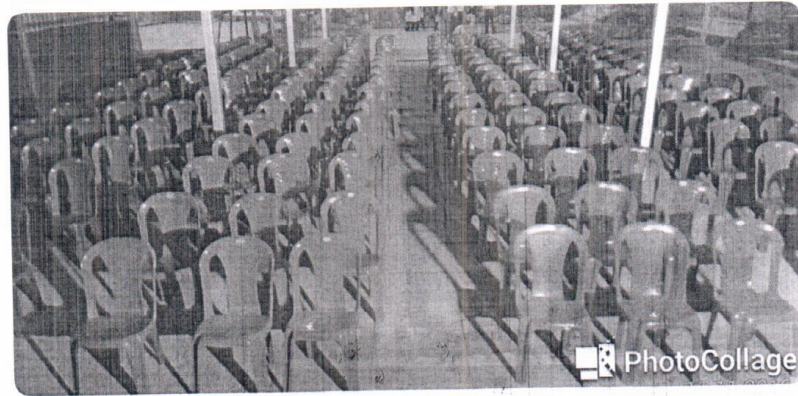
Front view of the Building



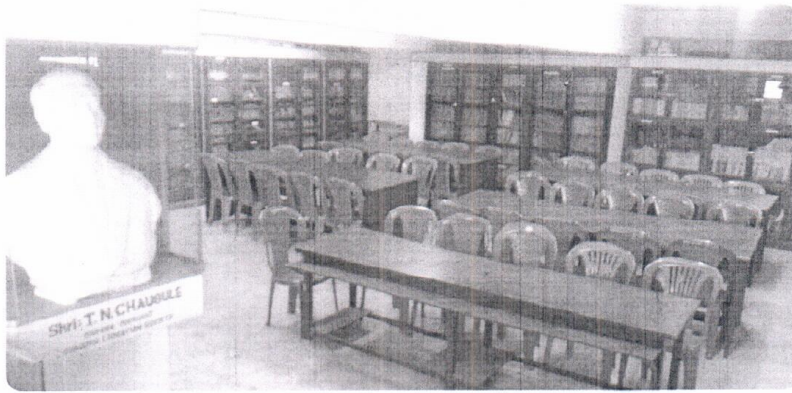
Rear view of the building

Library-cum-Reading room

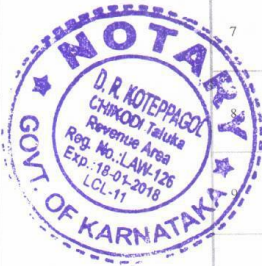
